Every seller making retail sales and every person performing services as required shall, on or before the last day of the month succeeding the end of each quarter year ending March 31st, June 30th, September 30th and December 31st, make out a return for the preceding quarter year, upon forms provided by the City Clerk, setting forth the amount of all sales and services, all non-taxable sales and services, and all taxable sales and services for such preceding quarter, the amount of tax thereon, and such other information as the City of Anderson may require, and sign and transmit the same to the City of Anderson, and payments of the tax shall be remitted at the time of transmitting the return.

In the event the tax is not paid before delinquency as herein provided the Penalty and Interest shall apply and accrue and be collected in the same manner the delinquent tax is collected.
